Implementation of guidelines of statutory or regulatory bodies

The institution has constituted committees such as Anti Ragging Committee, Anti- Sexual Harassment Cell and Student Grievance Redressal Cell to address and resolve any grievances arising within the institution.

As per the provisions of "UGC Regulations on curbing the menace of ragging in Higher Educational Institutions,2009", the college has set up an Anti-Ragging Committee to keep a watch and prevent incidents of ragging in the campus. It aims to foster healthy interpersonal relations among students in the campus. The institution has implemented a wide range of measures in line with the guidelines to proactively address and prevent instances of ragging. For instance, students are mandatorily required to fill the Anti-Ragging affidavit on the Anti-Ragging website of the UGC. To promptly identify any occurences, strategic locations within the campus have been equipped with surveillance cameras. Regular interaction and counselling with the students are conducted to detect early signs of ragging and identification of trouble-triggers. Anti-ragging workshops and seminars are conducted to spread the idea among the students.

As per University Grants Commission (Prevention, Prohibition and Redressal of Sexual Harassment of Women Employees and Students in Higher Educational Institutions) Regulations, 2015, the college has an Anti-Sexual Harassment Cell, which is now renamed as Internal Complaints Committee (ICC). The college regularly conducts training programmes on gender sensitisation and women rights to sensitise students and staff regarding the same. Services of the college counsellor are also made available to the students.

As per MG University Students' Code of Conduct Rules-2005 and UGC order F.No 14-4/2012 (CPP-II), University Grants Commission (Grievance Redressal) Regulations, 2014, the college ensures that student grievances are addressed in a fair and transparent manner.

Complaint boxes are placed in designated locations in which students can drop in their grievances. A link has been provided in the college website for students to conveniently express their concerns and submit grievances. They may also mail their complaints to <u>mtcwgrievances@marthomacollege.ac.in</u>. The Cell Convenor periodically checks if any grievances are submitted so that they are promptly addressed and attended to.

Every year, all the above committees undergo a process of reconstitution to uphold transparency and facilitate unbiased and efficient resolution of grievances.
