
The college is dedicated to ensuring a secure and conducive learning environment for the students. For this purpose, various statutory committees are established including Anti-Ragging Committee, Internal Complaints Cell , Student Grievance Redressal Cell, Equal Opportunities Cell, SC/ST Cell etc all aimed at addressing and settling any issues or complaints within the institution. At the commencement of every academic year, the College Union organises an Orientation Programme for the students and parents of first year undergraduate courses. During this programme, they are given awareness regarding the various statutory committees constituted in the institution. They are familiarised with the institution's structures, mechanisms and procedures, including zero- tolerance policies and specific procedures for addressing student grievances. They are also given an overview of the institution, its various departments, facilities and the different student support clubs and activities carried out throughout the year.

Students are addressed by their respective Heads of Departments during department-specific induction meetings. The department association meetings are systematically conducted to address students' grievances and concerns. Anti- ragging documentaries are screened in the college library for the first-year students. To raise awareness among students, anti- ragging posters are strategically placed at prominent locations on the campus such as corridors, hostel, canteen etc. In order to ensure students' awareness about the functioning of the cells and committees responsible for their rights and safety on campus, boards displaying the names and contact details of the respective cell coordinators are installed. Students are also mandatorily required to fill the Anti-Ragging affidavit on the Anti- Ragging website of the UGC.








